Mayor Kaplan stated that earlier this evening board members met at Westwood Avenue to discuss the subject allowing parking on the south side of this street between Linden Street and Laurel Terrace. Chief Mattracion commented that he believes if the board allows parking there it would become a safety issue since the road is a narrow one. Chief Mattracion also stated that Westwood Avenue is one of the first streets in the Village to freeze during a storm and this should be taken into consideration before any decision is made. Mr. Slee, who owns a home in the area being discussed feels this street is not any narrower than other streets in the Village that allow parking on one side of the street. As an alternative to parking on the street, the board would like to explore the possibility of allowing parking on the grass in front of their homes in this area on a seasonal basis.

ENGINEER'S REPORT

Don Fletcher and Don Schmalzle, Barton & Loguidice were before the board tonight to discuss task orders for engineering and project design services. Mayor Kaplan commented on the three projects that the board feels is extremely important and there are:

- 1. GUIDI mandate program
- 2. Completion of Mapping of the Water System
- 3. Water Values identification and repairs

Mr. Fletcher stated that the task order he is presenting is for permitting and design of the Priority One and Priority Two water system improvements as noted in the Facilities Plan. The three portions for the entire project was for \$7,800,000 but the board is only interested at this time of improvements totaling \$5, 800,000. Mayor Kaplan inquired if the Board votes for only the three items would the Village still be eligible for the \$2,000,000 grant from Environmental Facilities Corporation (EFC)? Mr. Fletcher is working with the EFC to receive this grant and also an interest free loan.
