Mayor Kaplan told audience members that the Village will be receiving a grant for the lighting project in Liberty Square.

Mayor Kaplan also spoke about a resolution that was passed at the last Village Board meeting in reference to authorizing the Manager to enter into an agreement with Marshall & Sterling to review existing insurance policies, prepare specifications for bids, assist and advise the Village in selecting insurance bids. Mayor Kaplan requested a motion to amend that resolution as follows:

MOTION AMENDING RETAINING INSURANCE CONSULTANT #22811-1

Motion by Deputy Mayor Younger, seconded by Trustee Lopez to amend motion #21411-10 authorizing the Village Manager to retain an insurance consultant. The amendment will be that the consultant will not prepare the specifications for our insurance but only review the proposals when they are received at a cost of \$85.00 per hour.

Motion by Trustee Steinhoff, seconded by Deputy Mayor Younger to accept the minutes of January 24, 2011 as presented. All in favor - Aye - motion carried

PETITIONERS & CORRESPONDENCE

Michael Halliday – 79 & 81 Center Street – Mr. Halliday was before the Village Board tonight to discuss his frustration with the Planning and Zoning Board of Appeals when they would not allow him to have a handicap apartment on the first floor of his building. Mayor Kaplan discussed the reasoning behind those boards decision and he will look into the matter.

<u>Shadowland Theater</u> – Brendan Burke, Director, Shadowland Theatre among other board members of the theater were at the meeting tonight requesting the Village of Ellenville's financial support for the upcoming year. Mayor Kaplan thanked him and their board and while working on this next fiscal budget will consider their request.

<u>Ellenville/Wawarsing Youth Commission Minutes</u> – Board members acknowledged receipt of the Youth Commission's recent minutes.

<u>Joel Schreibman</u> – Mr. Schreibman spoke about the recent Request for Proposal for the Village website and also Channel 23 cable station. Also discussed was the placement of the video equipment, etc. to record and show Town and Village Board meetings and it was the consensus of the Village Board to house the equipment at Town Hall.

DISCUSSION

Inter-municipal Youth Services Agreement - Mayor Kaplan reviewed with board members an agreement between the Village of Ellenville and the Town of Wawarsing for Youth Services. The Town and Village will share equally the expenses for the "school pool" and for in-kind services that will be done at the pool. Also discussed was that the Town Board will hire staff based on the recommendations of the Youth Commission board.

Manager Sheeley read a letter from the YMCA Kingston program to parents at the Ellenville Central School District informing them that their After-School Program will be cancelled effective April 4, 2011.

POLICE

Chief Mattracion reported that "Run Like The Wind" committee will be meeting with Lt. Doria to plan this event. Chief Mattracion also told board members that he has met with the Pastor of the Seventh Day Adventist about their Palm Sunday event and board members requested that this group come to the next board meeting to discuss their plans.

Manager Sheeley presented to board members the results from the recent bid for Sludge Removal.
