<u>Historic Preservation Commission</u> – Letter received from Marion Dumond in reference to the State Review Board's consideration for the nomination of Christ Lutheran Church.

Muhammad Raman – 53 Market Street – Mr. Raman was before the board tonight to discuss two issues. The first was a charge for shoveling is property on December 10. Mr. Raman stated that he was out of the country at that time and requested the board waive this fee. No action was taken by the board.
