# Village of Ellenville Board Meeting Monday, March 12, 2012

The meeting was called to order with the Pledge of Allegiance by Mayor Jeffrey Kaplan at 7:00 p.m.

Mayor Kaplan introduced Chairperson Terry Bernardo of the Ulster County Legislative. Legislative Bernardo stated that since she has been elected Chairperson she has been visiting all the Towns and Villages to introduce herself and questioned if there was anything the County can do to help the local municipalities. Mayor Kaplan stated that the Villages in our County are not made whole for taxes that are not collected and requested that the County look into this matter since it would benefit the Village tremendously.

# PETITIONERS & CORRESPONDENCE

Time Warner Cable - Correspondence in reference to channel additions/deletions.

Ellenville/Wawarsing Youth Commission Minutes – The Village Board acknowledged receipt of their minutes.

EWCOC – Request from the Chamber of Commerce for the Village's assistance in reference to the Shawangunk Mountain Blueberry Festival being held on August 11, 2012 for street closures and police personnel. Mayor Kaplan requested that the Chief of Police contact the Chamber to coordinate efforts.

Mayor Kaplan read a letter that he received from the U.S. Department of Justice complimenting Chief Mattracion on his recent assistance in apprehending an individual who was believed to be responsible for a number of violent felonies. Mayor Kaplan also commended the Chief on a job well done.

#### POLICE DEPARTMENT

Chief Mattracion informed board members of a recent situation that took place where two of his officers performed life saving measures on a male subject. Chief Mattracion presented a Certificate of Meritorious Police Service to Sgt. Jeffrey Van Asselt and Patrolman Anthony Yonne. Ulster County Legislator Bernardo also presented these two officers with Pride of the County certificates.

Chief Mattracion also spoke about several recent incidents involving graffiti on buildings. Some buildings have been painted over and this graffiti is not gang related.

Chief Mattracion requested to attend a seminar on taser guns being held in Syracuse.

APPROVAL OF ATTENDANCE TO SEMINAR-USE OF TASER GUNS #031212-2

Chief Mattracion informed board members of in-service training that will take place for his department on March 24, 2012.

#### MANAGER'S REPORT

Service Line Repairs – Manager Sheeley gave to board members a breakdown of the Village costs (for the past fiscal year) since the

Village code had been amended in 2008 in reference to the maintenance of the responsibility for service lines. At this time the Village maintains the portion of the service pipe extending from the corporation top to the curb cock. Discussion ensued about changing this section of the code to read that the Village is responsible for maintenance of the service line to the valve. There is a Public Hearing scheduled at the next board meeting to discuss this further.

Water Rates – At the present time the Water Fund has a deficit of \$259,747. Mayor Kaplan stated that our minimum rate of \$21.00 for the first 5,000 gallons of water used is very low and the Board should consider raising that number. Different minimum rates were discussed and what revenue would be raised by doing so. The Water Fund is incurring a monthly deficit of \$30,000 and board members feel that this issue needs to be addressed now. After a lengthy discussion and many different opinions as how to rectify the deficit and in addition to obtain \$30,000 monthly it was decided that a raise in the minimum rates as well as adding a surcharge to cover the deficit fairly among on the water rates would be instituted.

In addition a meeting will be scheduled with the School District to sort out the responsibilities of maintaining the field while they are using it.

Budget Workshops – It was the consensus of board members to hold budget workshops beginning at 5:30 p.m. on March 26 & March 28, 2012.

Mayor Kaplan requested that "Neighborhood Walks" be placed on the next agenda.

#### ATTORNEY'S REPORT

Attorney Berger spoke about an agreement with Country Financial which is scheduled for a vote later this evening.

Timber Harvesting – discussion will be scheduled at the next board meeting.

#### **BUILDING DEPARTMENT**

Ellenridge Booster Pump Station - Mayor Kaplan inquired about the status of this project and Code Enforcer Schug responded that he spoke to the Ulster County Health Department today.
