This land is currently used as a mini park with sidewalk passing through the center. This parcel is 4,288 square feet and 5,000 square feet is needed for a subdivision.

Attorney Berger commented that there is no practical use for this lot and the variance needed is less than 800 feet.

There was discussion if a variance is granted that a stipulation be placed stating that this parcel is only to be used as open space and not for any other use unless prior approval is received by the Village Planning Board.
