APPROVAL OF MINUTES #041309-01	Motion by Trustee Steinhoff, seconded by Trustee Oliveras to approve the minutes of March 23, 2009 as presented. All in favor - Aye - motion carried		
ENGINEER'S REPORT	Glenn Gildaly, Barton & Loguidice, gave an update on the progress of the proposed wastewater treatment plant. Mr. Gildaly told board members that the USDA Rural Development is offering the Village of Ellenville \$2.1 million in grant funding and \$5 million loan at 3.75%. Mr. Gildaly will be meeting with Congressman Hinchey about federal funds that may be available for this project. In addition, Mr. Gildaly stated that the \$2.1 million grant is the largest grant given by the USDA Rural Development in the Hudson Valley. Also discussed was the facility tour that will be done on April 28 by the NYS engineer and that Barton & Loguidice is approximately 50% done with the design of the new plant. Mayor Kaplan stated that the Board has requested that the Village Treasurer to do an analysis of what the impact would be on Village residents on their sewer rate if a new plant is constructed.		

RESOLUTION TO APPLY FOR FUNDING UNDER GREEN INNOVATION GRANT PROGRAM #041309-02

Resolution by Trustee Steinhoff, seconded by Trustee Lopez:

Whereas the central Waste Water Treatment Plant (WWTP) has outlived its useful life and;

Whereas, the Village of Ellenville is seeking affordable financing to design and build a new WWTP; and

Whereas, the Village, in pursuit of due diligence and with the interests of District ratepayers in mind, has made application to a number of State and Federal funding agencies; and

Whereas, the Village is seeking to incorporate "green" technology and a high level of energy efficiency in the new WWTP; and

Whereas the NYS Environmental Facilities Corporation (EFC) recently announced the availability of funding under the Green Innovation Grant Program (GIGP); and

Whereas the GIGP is part of the American Recovery and Reinvestment Act of 2009 (aka The Federal Stimulus Bill) and is designed for projects that can commence construction no later than January 01, 2010; and

Whereas, the GIGP can pay for 90% of the cost of innovative technologies that are anticipated in the WWTP Upgrade Project; and

Whereas, the GIGP requires a 10% match and the Village intends to meet this requirement through USDA grant funds and/or other leveraged funding; BE IT RESOLVED;

That the Village Board of the Village of Ellenville hereby authorizes the Mayor to submit and sign any/all documents that are required to participate in the GIGP and to submit such documents to the EFC no later than May 29, 2009.

DISCUSSION ITEMS

<u>Village Bus</u> – Manager Sheeley told board members about a visit from a representative from the NYS Department of Transportation where a Village owned bus was observed at the Kingston school picking up students and then dropping them at the YMCA after school program and it did not have the proper inspection sticker to transfer students on this bus. Mrs. Sheeley further stated that the Village was unaware that our bus was in Kingston and calls were made to our local YMCA director, Sam Bugna, to inquire about and rectify this situation. Mrs. Bugna who is also a representative of the Ellenville/Wawarsing Youth Commission was present and stated that the bus was donated to the Youth Commission and the commission voted to allow the YMCA to use the bus. There was discussion among board members that since the title of the bus and the insurance is in the Village of Ellenville's name the Village must consent to the use of the bus by a third party..

MOTION THAT ANY USAGE OF THE VILLAGE OWNED BUS BY ANYONE OTHER THAN ELLENVILLE/WAWARSING COMMISSION IT BE PRE-APPROVED BY THE BOARD OF TRUSTEES #041309-04

Motion by Trustee Steinhoff, seconded by Trustee Oliveras to continue to allow the Ellenville/Wawarsing Youth Commission to use the bus for themselves but if anyone else request to use the bus it will need to be pre approved by the Board of Trustees. All in favor - Aye - motion carried

It was requested that we inquire about the different inspection specifications needed when transporting students. Mayor Kaplan asked Mrs. Bugna to give an update on the upcoming summer program and she replied that as of today there are 100 children registered and the program runs for seven weeks from the hours of 8:00 am - 4:30 pm at a rate of \$210.00. Mrs. Bugna told board members about a program that Best Buy sponsors for their employees that volunteer in their community. Their employee, Ben Avery, has been a coach in our area and Best Buy will be donating \$3,000 this Saturday to the Ellenville/Wawarsing Youth Commission. PETITIONERS & CORRESPONDENCE

Lanette Hughes – 13 Center Street – was before the board tonight to discuss a "safe house" that she operates from her residence and was inquiring about any grant funds that may be available to repair her home. Mayor Kaplan questioned Code Enforcer Schug if the use of Ms. Hughes' house is allowed in her area. Mayor Kaplan also suggested that Ms. Hughes contact Dan Hauspurg our Economic Development Officer.

<u>Paul Block</u> – Mayor Kaplan told board members that Mr. Block is currently working on auditing the Village of Ellenville's utility bills and is before the board tonight to discuss a proposal to supply electric power for our buildings. After Mr. Block's presentation it was requested that he supply us with a list of other municipalities that his company services.

<u>Habitat for Humanity</u> - 46 Clinton Avenue – Mr. Bizovi was before the board tonight requesting that the \$100 fee for the curb cut at this new residence. <u>Wawarsing Council of Agencies</u> – The Board of Trustees acknowledged receipt of their minutes.

MOTION TO WAIVE FEE FOR CURB CUT #041309-07

Motion by Trustee Lopez, seconded by Trustee Steinhoff to waive the \$100 fee for Habitat for Humanity's curb cut at 46 Clinton Avenue. All in favor - Aye - motion carried

In addition Mr. Bizovi requested that the Village of Ellenville personnel do the curb cut and it was the consensus of board members that Habitat uses a professional contractor to perform this task.

<u>Joel Schreibman</u> – questioned the status of the Cable Franchise agreement and Attorney Berger will give an update at the next meeting. Mr. Schreibman also spoke about the possibility of a grant for a public access channel sponsored by Provident Bank in reference to web casting Village Board meetings. In addition, Mr. Schreibman requested an update report from the Dissolution Committee.

<u>NYS Department of Public Service</u> – correspondence received informing the public of a proposed increase by Central Hudson. It was requested that this information be posted on our website.

<u>Joanne Joray</u> – 5 Maiden Lane – requesting a sign be placed in front of her home advising drivers to slow down since her son uses a wheelchair to cross the streets. Mayor Kaplan requested that Chief Mattracion review this matter and report back at the next meeting.

<u>Franco Rossi</u> – 27 Market Street – requested to have the snow removal charges waived that were incurred during the winter. No action taken.

<u>Sidewalks</u> - Mayor Kaplan questioned Manager Sheeley about the status of the grant received for sidewalks in the Warren Street area. Mrs. Sheeley reported that Barton & Loguidice has agreed to honor a quote they gave in 2005 to complete the specifications, acquire DOT permits, review the bids and oversee the sidewalk project.

MOTION TO APPROVE EXPENDITURE TO BARTON & LOGUIDICE FOR SIDEWALK SPECIFICATIONS #041309-08

Motion by Trustee Steinhoff, seconded by Trustee Oliveras to authorize the expenditure of \$9,510.75 to Barton & Loguidice for the Warren Street sidewalk project. All in favor - Aye - motion carried

<u>Beckley Drive Bridge</u> – Glenn Gildaly told board members if the Village of Ellenville does receive stimulus money it should be in April.

Steve Krulick questioned that if the Hickory Street Bridge is still on the list for repairs and was told that this project's timetable has been postponed to 2014 by the Department of Transportation.

<u>Excavations & Soil Mining</u> – Code Enforcer Officer Schug told board members that the amendments to this section of our zoning law has been reviewed by both the Ulster County Planning Board and the Village of Ellenville Planning Board and is requesting that the Village Board review and consider these amendments.

Mayor Kaplan asked for any public comments and Brian Rubin requested a synopsis of the budget. Mayor Kaplan stated that the Board of Trustees is committed that this will be a balanced budget but the board is not in a position at this time to give a final tax rate. There was discussion about the deficit and is hopeful this budget will show a surplus. Also questioned if the board is considering using the "mountain money" and was told it had been discussed.

MOTION ACCEPT PROPOSAL FROM RESIDUALS MANAGEMENT SERVICES, INC. #041309-14

Motion by Trustee Oliveras, seconded by Trustee Steinhoff to accept proposal from Residuals Management Services, Inc. in the amount of \$6,300 for the transportation and disposal of approximately 40 yards of grit screenings. This expenditure will take place after June 1, 2009. All in favor - Aye - motion carried

BUILDING DEPARTMENT

Code Enforcer Schug reported that the railing in front of the police station has been completed as well as the fire alarm system on the third floor.

Code Enforcer Schug told board members about correspondence received from the NYS Department of Environmental Conservation in reference to National Flood Insurance Program Insurance Rate Maps for Ulster County and it is necessary for the Village of Ellenville to adopt these new study and map.

MOTION TO SCHEDULE A PUBLIC HEARING #041309-15

Motion by Trustee Lopez, seconded by Deputy Mayor Younger to schedule a public hearing on May 11, 2009 at 7:45 p.m. to discuss adopting Local Law #4 of 2009 which will amend or adopt the flood maps for Ulster County. All in favor - Aye - motion carried <u>Ellenridge</u> – Mayor Kaplan requested an update on the construction of the pressure booster station and payment of the engineer fees owed to the Village of Ellenville.

TREASURER'S REPORT

Village Treasurer Polkoski presented the bills for audit and discussion about the bond counsel agreement will be discussed at the next meeting.

MANAGER'S REPORT

Manager Sheeley spoke reviewed with board members a volunteer policy and Trustee Steinhoff questioned if they are entitled to workers' compensation if an injury occurs. Manager Sheeley will check with Sprague & Killeen and Ulster County Self Insurance.

<u>Grants Update</u> – Manager Sheeley reviewed with board members status of Village grants.

BOARD REPORTS

Trustee Oliveras questioned if the floor mats used in the building are under contract, the Sewer Department truck that is used to transport the sewer jet and also would like to reduce \$700 of his trustee compensation back to the general fund.

Motion by Trustee Oliveras, seconded by Trustee Steinhoff to reduce the Mayor and Board of Trustees compensation by \$200 each.

All in favor – 4; Nay – 1 - Deputy Mayor Younger Motion passed

Trustee Steinhoff commented that a Youth Commission meeting has been scheduled for April 30 and spoke about the program of students turning off their TV for a day.

Mayor Kaplan spoke about the 10 x 10 x 10 art program will again take place this year and also the Farmers Market will begin and June 22 and run through October 4. There will also be weekly entertainment. Mayor Kaplan also spoke about students from Ulster County Community College showing their work at the Arts Wave building.

Trustee Lopez requested Mr. Schug to look into a conflict between two neighbors on the corner of Market and Canal Streets.
