## Village of Ellenville Village Board Meeting Monday, April 25, 2011

Budget workshop began at 6:30 p.m. and the meeting called to order at with the Pledge of Allegiance by Mayor Kaplan.

Mayor Kaplan began the workshop stating that New York State has increased the cost of health insurance and retirement contributions for Village employees by approximately 20% for the coming year.

First draft of the budget without any reduction of staff was close to a 12% increase for taxpayers. This number is unacceptable and board members would not vote for a tax increase that high.

There was discussion about a reduction in staff which would bring the increase to 6.7%. Also discussed was the possibility of Village employees taking a zero percent raise for the 2011/2012 budget year to avoid layoffs.

Deputy Mayor Younger spoke about his review of the budget numbers and would like some other ideas for reduction from the public.

Trustee Lopez wants to save jobs without burdening the taxpayers.

Several audience members questioned what we do about deadbeat taxpayers, health insurance cost, and repayment of a sewer camera and chipper that was never purchased.

Judge Parker along with Judges Toomey and Delahart spoke about the many responsibilities that a court clerk has and that the position should remain full time.

Code Enforcer Schug gave to board members the Planning Board's advisory opinion of draft legislation for the following addition to Section 227-28 in the Village Code:

"Notwithstanding the foregoing, single bedroom apartments occupied by persons determined to have a physical impairment that would make it difficult for an occupant to navigate stairs may be located on the ground or street level, on the same floor or the floor below any non-residential use, if the apartment is fully handicap accessible and the apartment does not front on the public street."

It was the consensus of the Planning Board members that numerous handicap accessible apartments are available at Glusker Gardens and the Ellenville Senior Housing if there was need. In addition it was their thought that the Village would be in danger of losing our commercial corridor. The Planning Board is not in favor of this addition to the Ellenville Zoning Code.
