MOTION GRANTING PERMISSION TO HOST A VOTER REGISTRATION TO EMPOWER ELLENVILLE #040912-1

Michael Moschetta, Scoresby Fire Department and Steve Grundt, Ellenville Fire District were before the board tonight requesting permission to host an event to recruit volunteers to their organizations. This event will take place on April 21 & 22, 2012 from 8:00 am – 4:00 pm. Chief Mattracion stated that he has spoken to both gentlemen and they have made the necessary arrangements for traffic control.

MOTION TO AUTHORIZE RECRUITMENT DAY TO ELLENVILLE FIRE DISTRICT #040912-4

Motion by Trustee Steinhoff, seconded by Trustee Lopez authorizing the Ellenville Fire District to close a portion of Liberty Street from Route 209 to the end of Scoresby property on April 21 & 22, 2012 from the hours of 8:00 am – 4:00 p.m. The Fire District will be hosting an event for the recruitment of volunteers. Mayor Kaplan on behalf of the Village Board thanked the Fire District for all their efforts over the past weekend.

Dan Mangieri spoke about his recent water/sewer bill and discussed the rising rates and his inability to pay these amounts.

Rick Weinman – Discussed his water/sewer bill, abandoned cars, litter and his dissatisfaction with the Village Manger and Village Board.

Motion by Trustee Lopez, seconded by Trustee Steinhoff to open the Public Hearing for the 2012/2013 Village Budget at 7:15 p.m. All in favor - Aye - motion carried

Different line items were reviewed and the following motions were made:

Motion by Trustee Lopez, seconded by Trustee Steinhoff to amend the Judicial salary budget line to \$49,500.

Motion by Trustee Lopez, seconded by Trustee Steinhoff to reduce the engineering budget line to \$20,000.

There was discussion in reference to reducing the Police Salary line to \$1,050,000 and increase the retirement line to \$165,705. Mayor Kaplan requested that the Village Manager and Treasurer meet before the next board meeting and review these changes.

Motion by Trustee Steinhoff, seconded by Trustee Oliveras to reduce the Street Snow Removal line to \$50,000.

Motion by Trustee Steinhoff, seconded by Trustee Oliveras to add \$500 to the Arts Initiative Line.

All in favor – Aye – motion carried

Motion by Trustee Steinhoff, seconded by Trustee Oliveras to add \$250 to the Farmer's Market Line.

Elliott Auerbach inquired about the tax levy cap, our Debt Service and employee benefits.

Motion by Trustee Steinhoff, seconded by Deputy Mayor Younger that the Village suspend collection of sewer capital assessment fees on vacant lots effective April 1, 2012 going forward until such further information in obtained.

Chief Mattracion discussed with board members the establishment of a safe room in the Government Center and also the installation of a deadbolt lock in the Court/Meeting Room as well as the Processing Room on the second floor.

MOTION AUTHORIZING T. VAN LEUVEN TO ATTEND NYRWA CONFERENCE #040912-11

TREASURER'S REPORT

Payment of Village taxes in two payments – Treasurer Polkoski reviewed with board members the option that Village residents could pay their Village taxes in two payments. Attorney Berger and UC Comptroller Auerbach discussed how this is done in other municipalities.

MOTION TO ACCEPT VILLAGE TAX PAYMENTS IN TWO INSTALLMENTS #040912-13

Motion by Trustee Steinhoff, seconded by Deputy Mayor Younger to accept payment of Village taxes in two installments provided that the first installment is received no later than July 1st of the installment year. Penalty and interest will be assessed at 5% after July 1st and an additional 1% each month thereafter on the unpaid balance.

BUILDING DEPARTMENT

48-50 Chapel Street – Code Enforcer Schug stated that he has put this property owner on "Notice of Dangerous Building" on April 3, 2012 and Mr. Selesky has 6-10 days to appeal this notice. Mayor Kaplan requested that Attorney Berger check State law to see what options the Village has for collecting money expended if the demolition costs are incurred by the Village. Deputy Mayor Younger stated that they letter does not state that the property owner is responsible for the demolition fees if in fact the Village takes down the building and since it is unclear another letter will be sent to Mr. Selesky.

RESOLUTIONS

RESOLUTION FOR SHARED MUNICIPAL SERVICES #040912-14

Resolution by Deputy Mayor Younger, seconded by Trustee Oliveras

As the Village of Ellenville is seeking methods to lower property taxes and increase the efficiency services to local taxpayers; and As shared municipal services and/or consolidation of municipal departments can be a method to lower costs; and As the NYS Department of State administers as Local Government Efficiency Program that offers grants to support municipal government efficiency efforts;

Be it Resolved that:

The Village of Ellenville, Applicant, has authorized Mayor Jeffrey Kaplan and Village Manager Mary Sheeley to submit a grant request, in conjunction with the Town of Wawarsing, Co-Applicant, to the Department of State, requesting grant funds under the Local Government Efficiency Program, for the 2011-2012 program year.

This project, entitled, "Village of Ellenville and Town of Wawarsing Shared Highway Services" requests of a total of \$35,000, for the purpose of a Study to explore means/methods by which the Village Department of Public Works and the Town Highway Department, may be able to share services and equipment and/or consolidate services so as to result in tax savings for Village/Town residents.

By way of this Resolution, the Village Board authorizes Mayor Kaplan to sign any/all documents related to this project, as the Village will serve as Applicant.

Furthermore, the Village understands that there is a 10% Local Share for this project and the Village and Town are committed to the local share through in-kind services and/or cash with each contributing 50 % of the local share match. The total local share is \$3,500 with each community providing \$1,750 through in-kind services and/or cash.

RESOLUTION FOR HOME RULE REQUEST #040912-14

Resolution by Trustee Steinhoff, seconded by Deputy Mayor Younger:

Whereas, the Village of Ellenville has been notified that certain members of the Ellenville Police Department are not currently enrolled in NYS Retirement Section 384-d; and

Whereas, this error was strictly a clerical error with no involvement on the part of the employees themselves; and

Whereas, the Village of Ellenville desires to rectify this situation and restore these employees to their rightfully retirement system; and

Whereas, the Village of Ellenville has requested assistance from NYS Assemblyman Kevin Cahill and NYS Senator John Bonacic to craft State legislation to correct this error; and

Whereas, the New York State Legislature requires a home rule request from the Village of Ellenville in order to enact such legislation;

Now, therefore, the Village of Ellenville does hereby request special legislation assistance from both the New York State Assembly and the New York State Senate allowing the effected employees to be moved into Section 384-d of the New York State and Local Police Retirement System.
