RESOLUTION TO ADOPT LOCAL LAW #2 OF 2012 #051412-7

WHEREAS, the Village of Ellenville wants to amend Section 210-6 of the Village Code; and

WHEREAS, the Village Code currently provides for fees of \$275.00;

NOW, THEREFORE, BE IT enacted by the Village Board of the Village of Ellenville:

Section 210-6 shall be changed to read as follows:

"The fee for each license issued under Section 210-3 through 210-7 shall be set by resolution adopted by the Village Board and such licenses shall expire on the 15th day of May and may be renewed each year. A taxi license shall be deemed to have expired if the holder shall fail to renew a license on the renewal date set forth in this section."
