The meeting was called to order with the Pledge of Allegiance by Mayor Kaplan at 7:00 p.m.

Mayor Kaplan reported that earlier this evening members of the board went to 27 Maple Avenue to meet with property owner, Francesco Nunuvero, to discuss a variance that he would need to install a solid fence around his residence. Mr. Nunuvero was also present to discuss the matter further. Mayor Kaplan stated that the board would consider a four foot solid fence erected on the front and side of this residence; but since this fence would be between two properties it is felt that the adjoining property owner give his input. Mayor Kaplan requested that in the future when requests are made for variances before the Board of Trustees takes any actions, the Village notify the adjoining property owners.

Mr. Nunuvero commented that he has been in discussion with Mr. Kass and he does not have a problem with this request.

POLICE

Chief Mattracion reported on several incidents that have taken place in the Village and spoke about upcoming training that his personnel will attend.

Chief Mattracion spoke about his department's need for a new police car. and there was discussion about the financing that will need to take place.

The Chief gave an update on the ATVs activity in the Village and he has spoken to their owners as well as the enforcement of the "Scooper Pooper" law.

MOTION AUTHORIZING LEASING A NEW POLICE CAR #062314-4

- •Well Sites Nine sites have been identified for potential water sources letters will be sent to property owners
- ■Ida Lane Project Work is 80% completed
- •Collection of Past Due Taxes by Ulster County There is a public hearing being held on July 15th at Ulster County Community College to discuss this issue.
- •FEMA Reimbursement for the Ida Lane project will not be received until the end of the year.
