- The Board needs to approve Barton and Loguidice to make the plans and specs for Circle Avenue.
- Streetscape Grant The Village needs to meet and get the ball rolling on this project.
- Grant Committee Joint funding with the Town and Village GUIDI, Harris Well and USDA
- Hazard Mitigation Plan

PETITIONERS AND CORRESPONDENCES

<u>Joel Schreibman</u> – commented on the delay for the renewal of the Time Warner's franchise agreement.

The Mayor asked Attorney Berger to contact Brenda Parks, Director of Government and Public Affairs, to see if she would attend a Village Board meeting to discuss the Time Warner Franchise Agreement.

Mr. Schreibman also stated that between his property on Mine Lane and the Village salt shed there seems to be a parking lot and he noticed that construction trucks are being parked there. Trustee Lopez will check into this matter.

<u>Time Warner Cable</u>: Correspondences received from Time Warner Cable to advise channel changes and/or deletions.

<u>Ellenridge Homeowners Association</u>: Susan Picarillo asked about the erosion control problem at Ellenridge. The Board will look into correcting this matter.

The Board requested Attorney Berger to look into using the Ellenridge BOND money to correct the erosion problem in Ellenridge. Attorney Berger informed them that this potential litigation is an executive session matter and needs to be discussed in executive session. This discussion will be placed on a future executive agenda.

She also asked about the Ellenridge Pump station and Don Fletcher, from Barton and Loguidice, told her that he had not heard back from the Department of Health in regards to this matter.

Mrs. Finerow, who also represents the Ellenridge Homeowners Association, requested copy(s) of all certificate of occupancy issued to Ellenridge. The Board will instruct the Code Enforcement Officer to do so.

Mark Steinhoff discussed with the Board that between Visions on Center Street and the parking lot owned by the Village on Canal Street, the fencing is opened and cars are cutting through Vision's parking lot to enter Center Street. The Board will have the Street Department look into this.

<u>Hunt Memorial Preservation Committee</u>: The Hunt Memorial Preservation Committee requested to meet with the Mayor and Board of Trustees on October 26, 2009 at 6:00 p.m. The Board agreed to meet with them at 6:30 p.m..

Ellenville Wawarsing Youth Commission: Sam Bugna, Director of the Summer Program, presented the results of the 2009 Summer Program. She stated that the recreation program was a success with the exception of the school pool which is in dire need of repairs. Grant possibilities were discussed.

Trustee Oliveras inquired about the EFC Grant to replace the filter system at the Water Department. He also wanted to know when the grass by Scoresby Fire House and by D&M Furniture was going to be cut?

Trustee Steinhoff informed the Board that Glen Gidaly told her that the Village of Ellenville owes seven properties in the Village.

Mayor Kaplan would like the Code Enforcement Officer to contact Leather's and Associates to get a "new" punch list so that we can complete the playground and open it and wants the damaged planter replaced
