APPROVAL OF MINUTES

Motion by Trustee Younger, seconded by Trustee Lopez to table the September 13, 2010 minutes until October 12, 2010.

Mayor Kaplan and the Board of Trustees presented Certificates of Appreciation to the Boy Scouts, Troop 28 for their clean-up efforts on the Rail Trail located on Berme Road.

John Stanforth, from Troop 28, stated that he will bring in a list of items that Troop 28 will need in order to finish the bridge that is located on the trail.

While the Boy Scouts were present tonight, Mayor Kaplan discussed with them the day to day operations of the Village and introduced them to all Board members and Village Staff present at the meeting.

MOTION TO RESCHEDULE NEIGHBORHOOD WALK

Motion by Trustee Oliveras, seconded by Trustee Lopez to reschedule the Neighborhood Walk originally scheduled for earlier tonight beginning at Yankee and Canal Street to Tuesday, October 12, 2010 beginning at 5:00 p.m. as a result of inclement weather.

DISCUSSION ITEMS

Streetscape Project – Manager Sheeley advised the Mayor and Board that three bids that were received for the Streetscape Project but the bids were too high based upon the grant money available for this project. Manager Sheeley was reviewing the bids to see what items could be deleted without compromising the project. She stated that the work will be finished before the winter and the planting of the trees and flowers will take place in the Spring. Mayor Kaplan requested that changes for this project be done before the next board meeting.

Hunt Memorial South Façade Restoration Project – Kathy Butler, from the Hunt Memorial Committee, presented the Mayor and Board members with the bid results for the Hunt Memorial Restoration Project. Mrs. Butler stated that they received eight bids for this project and the lowest bidder was from Polonia Architectural Restoration of Astoria, Queens, NY for \$70,008. She asked that the Board award this bid to Polonia Architectural Restoration contingent on State approval.

MOTION TO AWARD BID FOR THE RESTORATION OF HUNT MEMORIAL SOUTH FACADE

Motion by Trustee Lopez, seconded by Deputy Mayor Younger to award the bid for the Hunt Memorial Restoration Project to the lowest responsible bid and that was Polonia Architectural Restoration, Astoria, NY in the amount of \$70,008 contingent on state approval.

MOTION TO APPROVE AN AUDITING FIRM FOR THE 2010/2011 FISCAL YEAR

He stated that C2G will be sending out a letter to the Engineers to approve the outstanding balance owed to Luzon after an independent inspection determined the equipment installed by Luzon was working properly.
