#### POLICE DEPARTMENT

Chief Mattracion presented his monthly activity report and told board members that he will give an in-depth presentation at the next board meeting.

Chief Mattracion spoke about the recent resignation of full time police officer Morse and would like to have a replacement appointment to that position. Mayor Kaplan requested that before any decision is made that the Chief meet with the Village Manager and Treasurer to discuss the budget impact.

Snow Plow Policy – Chief Mattracion questioned the policy about calling out the street department during inclement weather and Manager Sheeley will coordinate the procedure with Juan Caba and the Chief. Also discussed was the overnight parking of cars in the Village's parking lots and the Chief will have his staff obtain license plates and the Village office will notify the owners of the permit process.

Members of the Ellenville Police Department would like to schedule a workshop meeting with the Board of Trustees to discuss different issues.

#### **BUILDING DEPARTMENT**

NYS Department of Transportation – Highway Work Permit – Inspector Schug requested board members to authorize a 99 year highway work permit.

### RESOLUTION TO ENTER INTO A 99 YEAR AGREEMENT WITH NYS DOT HIGHWAY WORK PERMIT #011208-14

Resolution by Trustee Steinhoff, seconded by Trustee Lopez authorizing a 99 year agreement with the NYS Department of Transportation for highway work permit - PERM #1. All in favor - Aye - motion carried

<u>Fire Alarm Recommendations</u> – Inspector Schug presented to board members a quote from P.N. Alarm Company to install a fire alarm system on the third floor of the government building. Board members requested that Mr. Schug obtain quotes from other alarm companies.

<u>Sewer Main at RUPCO site</u> – Inspector Schug reviewed the following conditions that need to be met before the Village accepts ownership of the pump station. They are:

• RUPCO is to provide force main flushing equipment for the Village for use in force main cleaning and maintenance

• RUPCO to provide a backup control system for the pump station

• RUPCO to provide a hoist for removal of the pumps

These stipulations had been sent to RUPCO for the review and waiting to hear from them.

<u>Salt Shed Lightning</u> – Inspector Schug reviewed with board members three estimates that he had obtained in regard to the lighting in the salt shed.

### MOTION TO AUTHORIZE EXPENDITURE OF LIGHTING FOR SALT SHED #011208-15

Motion to authorize the installation of lighting for the salt shed subject to the availability of funds to Thornton Electric not to exceed \$3,012.

All in favor - Aye - motion carried

There was discussion about the damage that had been done at the salt shed by a delivery company and it was requested that Attorney Cataldi send a letter informing them if the repairs are not done properly the Village will have them done and send them the bill.

## **ATTORNEY'S REPORT**

<u>Antenna Farms</u> – This will be discussed at the January  $26^{th}$  meeting.

<u>19 Park Street</u> – Attorney Cataldi researched the issue of what could be done if court appearance tickets are ignored and informed board members that the penal law/criminal law allows for an arrest warrant to be issued. This past Friday was the deadline for their water bill also and Mayor Kaplan requested the property owner's phone number and he would contact them.

<u>Pedestrian Walkway Grant</u> – The Village of Ellenville will be receiving a \$294,000 grant and it was requested that the previous research done for solar lighting be updated.

### TREASURER'S REPORT

<u>Bond Anticipation Note</u> – Treasurer Polkoski reviewed with board members correspondence received from bond counsel in reference to the sewer plant improvements. There was also discussion about obtaining a bond for the HVAC improvements on the fourth and fifth floor of the government center.

<u>Youth Court</u> – Treasurer Polkoski stated that the Town of Wawarsing did not appropriate any funds in their 2009 budget.

Treasurer Polkoski commented that the cash issue is getting tight and request that all departments curtail spending unless there is an emergency.

## VILLAGE MANAGER'S

#### REPORT

<u>Streetscape Grant</u> – Manager Sheeley spoke about Senator Hinchey's grant in reference to this project. Mayor Kaplan stated that a design committee should be formed and this committee would include himself and Trustee Steinhoff.

<u>Government Center Issues</u> – Manager Sheeley spoke about the need for cameras in and around the building and is looking into the matter.

<u>104 Center</u> – A letter will be sent to this property owner reminding him that the snow and ice removal is his responsibility not the Village of Ellenville.

#### TRUSTEE CONCERNS

Mayor Kaplan spoke about the bus shelter that had been damaged in a recent storm and requested the owners be contacted and asked to attend a board meeting. Mayor Kaplan further reminded everyone that Village Hall has a drop off for print cartridges and cell phones which will be recycled for the Ellenville Playground Committee.

Deputy Mayor Younger questioned the ad revenues from the bus shelters and questioned the lighting that was to be placed in these shelters. It was requested that Adventra Graphics be invited to the next board meeting. Deputy Mayor Younger also spoke about the possibility of the UCAT bus changing their bus schedule.

Trustee Oliveras questioned if the new dump truck will be delivered this week.

Trustee Steinhoff commented that her and Trustee Oliveras conducted their audit meeting and requested that the utility bills be authorized to be paid upon receipt.

## MOTION TO AUTHORIZE PAYMENT OF UTILITY BILLS UPON RECEIPT #011208-16
