The Village Board met has 6:30p.m. for the purpose of auditing bills.

#### **PRESENTATION**

Antoinette King from Linstar was present tonight with the Chief of Police to demonstrate to Board members "body worn cameras" for our Police officers. Ms. King stated that the cameras can record audio and video as well as snap still pictures. Mayor Kaplan stated that before any cameras are used the board will need to review proposed rules and regulations as well as a positive recommendation from the Village's insurer, NYMIR.

Chief Mattracion stated that a local business has offered to donate \$2,400.00 for the purchase of these cameras.
