#### **PRESENTATION**

# PETITIONERS & CORRESPONDENCE

Diane Turner, Ellenville/Wawarsing Chamber of Commerce, was before the board tonight to discuss the possibility of banning dogs and other animals from the Blueberry Festival. In the past at the festivals, dogs have caused problems and her committee would not like to this occur again. Mayor Kaplan asked board members their opinion on this matter and before any decision is made, have the Village Attorney make sure the Village has the right to do this.

John Lopez, Men's Softball League reported to the Board that he has purchased a net to shield the playground from any balls that may go over the fence. Mayor Kaplan stated that the field would not be available until the Ellenville High School's season is ended.

Motion by Trustee Steinhoff, seconded by Trustee Lopez giving approval for Ellenville Men's Softball League use of the Berme Road field with the following conditions:

- Maintain the filed
- Certificate of insurance naming the Village of Ellenville as additional insured

- Install poles and netting under the supervisor and coordination with the building department.
- Use only limited flight softballs
- Use of field no later than midnight
- No smoking or alcohol use at the park
- No use of field on Sundays before 1:00 p.m.
- The season to begin when Ellenville School District is done with the field

#### POLICE DEPARTMENT

Chief Mattracion reported on a recent drug raid that took place in the Village in conjunction with many other police agencies. Also reported was training the Chief attended in reference to School Safety. In the near future, In-service training for his staff will take place, update on the Cinco de Mayo parade and Run like the Wind.

Mayor Kaplan spoke about the Chief's request for a new police car in the upcoming budget year and would like to have the Village's mechanic assess all his department's cars.

#### **MANAGER'S REPORT**

Manager Stoeckeler gave an update on Moisture Barriers bid bond who were originally awarded the Government Center roof bid, but have since then went out of business. Maximum of payment of default is 5% of the bid bond.

# MOTION AUTHORIZING MAYOR TO EXECUTE AN AGREEMENT WITH MOISTURE BARRIERS #041614-6

Motion by Trustee Steinhoff, seconded by Deputy Mayor Younger authorizing the Mayor Kaplan to execute an agreement with Moisture Barriers for the Release and Discharge of Bid Bond upon payment of 5% (\$6,115.00) due to the Village of Ellenville for default by Moisture Barrier and performance of its accepted bid upon recommendation of Village Attorney.

Memorandum of Agreement – Ellenville Police Benevolent Association – upon review of the current contract an error was found in the section relating to uniform allowance and the PBA agreed to amend this section.

Mayor Kaplan and the board thanked Traci Jeter for bringing this matter to everyone's attention.

#### MOTION AUTHORIZING MAYOR TO SIGN MOA WITH PBA #041614-7

Motion by Deputy Mayor Younger, seconded by Trustee Oliveras authorizing the Mayor to sign a Memorandum of Agreement with the Ellenville Police Benevolent Association in reference to uniform allowance. The Village Board appreciates the PBA's cooperation in amending the contract.

Jean Street Tank – Manager Stoeckeler discussed with the Board the need for an altitude valve for this tank. If this project is to be funded by EFC an engineer would need to be involved. Barton & Lougidice's fee would be \$6,160 and the fee for Ross, who would be installing the valve is \$5,750. Board members did not agree with the fee for Barton & Lougidice and the following motion was made.

#### MOTION TO RETAIN SERVICES OF ROSS #041614-8

Motion by Trustee Steinhoff, seconded by Trustee Oliveras to retain the services of Ross Contracting on an emergency basis for the installation of an altitude valve at the Jean Street Tank not to exceed \$5,750. All in favor - Aye - motion carried

Manager Stoeckeler presented the board with the Spring Clean Up Dates for 2014. In addition, Manager Stoeckeler met with the Shawangunk Country Club and they will be planting a crab apple tree in front of the Chamber of Commerce office.

#### **BUILDING DEPARTMENT**

Ulster County Multi-Jurisdictional Hazard Mitigation Plan-Building Inspector Schug has submitted this plan to the County and gave it to the board for their review.

Mr. Schug reviewed with the board a change order for the electric upgrade at the Hunt Memorial Building, installation of Liberty Square Light Poles, Government Center Roof Project and a change order for the work being done at the Street Department.
