Also Manager Stoeckeler told board members that he is awaiting a DEC work permit for the Hickory Street Bridge. In addition he gave an update on the repair of the signs located at the entrances of the Village, Government Center roof project, Canal Street parking lot lights, basketball poles on Berme Road, Liberty Square lights and the Safe Routes to School project.

Sixto Soto was before the board tonight to discuss the location of his snow cone ice cart. Mr. Soto cart's is currently located in Rivan Kreiger's lot on Canal Street and will be losing his lease to continue on this site.
