Mayor Kaplan suggested that at the next meeting formally present an achievement award to Justin Farrenkoff for winning the State Pole-vault and for winning the federation pole-vault. This was quite an accomplishment and terrific for the area.

Mayor Kaplan introduced two proposed applicants for the police department. . These two applicants, Taina Dempsey and Matthew Bagalnois come recommended by the Police Chief and were interviewed by Deputy Mayor Younger and Trustee Lopez.

He has a concern with softballs being hit over the fence and landing in the playground possibly injuring a child. PETITIONERS & CORRESPONDENCE

Mayor Kaplan stated that there was a letter received by this board from the Ulster Greene ARC with their plans to purchase a home on 5 Rosenstock Road to use as a group home for six autistic young ladies.

Mr. Salvatore Garozzo from Ulster Greene ARC and Ms. Jeanine Sisco from the Office of People with Development Disabilities were present tonight to discuss their plans for this property.

Mayor Kaplan stated that the Village Board had received a number of letters in opposition to this purchase from adjoining property owners, several of whom were at the board meeting to discuss their concerns.

This proposal was discussed at two prior Village Board meetings and the following resolution was sent to the Ulster Greene ARC:

"Motion by Trustee Steinhoff, seconded by Deputy Mayor Younger requesting that Ulster-Greene ARC not establish another individual residential alternative in the Village of Ellenville due to the fact that we have density issues here and are unable to afford or support another unit in such a small community when there are so few others in the County. All in favor - Aye - motion carried"

Ulster Greene ARC met with the Mayor and Village Manager last Thursday and requested that we will be bring this matter back to the Board and our office notified the neighboring residents of the proposed site about this meeting.

After a lengthy discussion between all parties present (approximately one hour) it was requested that the Village Manager Sheeley and Building Inspector look at other available properties within the Village that might an alternate site for this project and contact Mr. Garozzo with their findings. (attached is a verbatim transcription of the discussion.)

NAACP Youth Council Request – Letter received requesting a rally and youth walk on June 17, 2013 to represent the Youth who have joined the NAACP.

MANAGER'S REPORT

Manager Sheeley spoke about a Utility Agreement, KVS Summer Training and a request from the Nevele Investors for a Family Fun Day.

Mayor Kaplan mentioned that at the last Village Board meeting it was stated that before a letter was sent to the NYS Department of Transportation he would call them in reference to the Lucky Petroleum project and Auto Zone project. Mayor Kaplan did speak to them and they are awaiting additional paperwork from Lucky Petroleum and are in the process of working on the Auto Zone application. As such a letter will not be necessary at this time Mayor Kaplan.

<u>Nevele Investors – Family Fun Day</u> – The Nevele Investors are requesting to host a Family Fun Day on June 15 in Liberty Square with food and games and has offered to pay \$1,400 for the cost of police presence.

Mayor Kaplan has called Ulster County Executive Hein and has reached out to the Sullivan County Manger to start a dialogue about this resolution.

Noise Ordinance – Attorney Berger reported that the Noise Ordinance is our Village Code is comparable to other codes that he had researched.

Waiving Water/Sewer Late Penalties – The Village Board does not have the right to waive any late penalties. It was requested that Attorney Berger research if the Board wanted to change the schedule of when a late fee is assessed, could it be done by resolution or does it need to be done by a local law?
