PETITIONERS & CORRESPONDENCE

Raymond Libonte, Warren Street, was before the board tonight to discuss motor vehicles speeding on his block and requested that a "Children at Play" sign be posted as well as the placement of speed bumps. Mayor Kaplan responded that a sign can be placed but will check with the Village Attorney to see if speed bumps are legal on municipal streets. Chief Mattracion will conduct radar in the near future on Warren Street.

Mayor Kaplan spoke about the "Neighborhood Walk" that took place earlier this evening on Park Street. There is a house at 32 Park Street that appears to be in total disrepair especially the roof and it was requested that the Village Attorney research when a home is deemed unsafe at what point can the Village demolish the building. Also Park Street is in need of sidewalks and the Village has applied for a grant from Senator Bonacic's office to fund this project.

UC Community Action has requested that the building permit fee be waived for the upcoming repairs that will be take place at this structure.
