existing restaurant.

He noted the extensive renovations to existing buildings on Canal Street including the

Shadowland Theatre, and feels that any other façade would not be conducive to the area.

Commissioner Rosenstock was concerned with the color of the proposed structure.

Commissioner Maizer questioned placement of the dumpster for restaurant.

Code Enforcement Officer Schug stated that the Village of Ellenville allows dumpsters to be

placed on Village property with administrative approval.
