Commercial sewer minimum would go from \$68 to \$70 for the first 5,000 gallons, for usage from 5,000 gallons to 25,000 the rate would go from \$5.50 to &. \$7.50 per thousand and over 25,000 gallons would go from \$6.50 to \$8.50.
