- 1. Motion to award the Center and Canal Streets Sanitary Sewer Rehabilitation Project Bid to Keyon Pipeline Inspection, LLC in the amount of \$126,180.00 upon recommendation of Barton and Loguidice (the Village received the approval for the release of funds for this project).
- Motion to authorize the Village Clerk to advertise for RFPs (request for proposals) to operate a food service truck and or the restaurant at the Shawangunk Country Club with RFPs returned by noon on April 4, 2019 upon recommendation of the Village Manager.

- 3. Motion to authorize Michael Jeter to attend the 2019 Highway School Training at Ithaca College, Ithaca NY on Monday, June 3rd through Wednesday, June 5th in the amount of \$407.00 plus meals.
- 4. Motion to schedule 2019 Spring Clean Up dates from April 15TH May 10TH, 2019 upon recommendation of Street Department Foreman.
- 5. Motion to change the Mandatory Referendum Election from April 25, 2019 12 p.m. 9 p.m. to April 30, 2019 from 6 a.m. to 9 p.m. at the same location per Ulster County Board of Elections.
- 6. Motion to re-appoint Jeff Slade to the Joint Historic Preservation Commission for a new term, retroactive from end of his prior term December, 2018 upon recommendation of the Joint Historic Preservation Commission.
- 7. Motion to authorize the Mayor to accept and sign the proposal from Blauer Associates in the amount of \$3,750.00 for the 2019 CDBG Public Infrastructure project (\$1,875.00 is due upon execution of this agreement and the remaining balance of \$1,875.00 is due upon submission of the application). The term of this agreement will be April 1, 2019 to December 31, 2019.
- 8. Motion for the Board to declare itself as lead agency on Local Law #3 of 2019 Withdrawal from Special Reserve Funds.
- **9.** Motion declaring that the project is an "Unlisted Action "with no potentially significant impacts on the environment (Local Law 3 of 2019).
- 10. Motion that the Village of Ellenville has determined that the Consent Order Compliance Sewer Remediation Project (OCR #364PR152-18) is a Type II activity for the purposed of SEQRA and no further review is required.
- 11. - 14. Motion to adopt Local Law #3 of 2019 Withdraw from Special Reserve Funds for the acquisition of approximately 48 acres of land including the Shawangunk Country Club and Golf Course upon recommendation of the Village Clerk.
- 15. Motion to authorize the Village Clerk to go out to bid for the Emergency Shelter Electrical, Plumbing, General Contracting and HVAC with bids returned by noon on May 9, 2019.
