POLICE REPORT

Chief Mattracion gave an update of the status of obtaining prices for the purchasing a street cameras in the downtown business district. An initial quote of \$32,000 from Linstar was received and the Board requested the Village Manager to prepare a letter to State and Local officials inquiring about grant money to cover this purchase. Chief Mattracion further stated that he believes the purchase will decrease our insurance costs.

WHEREAS, the Streambank Restoration Project will also benefit residents of the Town of Wawarsing,

RESOLUTION AUTHORIZING SUPERVISOR TO EXECUTE INTERMUNICPAL AGREEMENT-NY RISING VILLAGE OF ELLENVILLE #020816-7

Resolution, on motion by Deputy Mayor Younger, seconded by Trustee Oliveras, the following resolution was put up for consideration and adoption;

WHEREAS, the Village of Ellenville and the Town of Wawarsing have each been awarded Community Development Grant-Disaster Recovery (CDBG-DR) funds from the NY Rising Community Reconstruction Program; and

WHEREAS, one of the projects selected is the construction/acquisition and rehabilitation of an emergency shelter/community center to be constructed within the Village of Ellenville; and

WHEREAS, the emergency shelter/community center will benefit residents of the Town of Wawarsing,

NOW THEREFORE, BE IT RESOLVED that the Village Board authorizes the Mayor to enter into an Intermunicipal agreement with the Village of Ellenville for the purpose of emergency shelter/community center construction/acquisition and rehabilitation to be funded by NY Rising Community Reconstruction and US Department of Housing and Urban Development (HUD) guidelines. The expected cost is to be \$1,200,000 with \$700,000 committed from the Village of Ellenville's NY Rising Community Reconstruction allotment and \$500,000 from the Town of Wawarsing's NY Rising Community Reconstruction allotment, subject to attorney's approval.
