Village of Ellenville Board Meeting Monday May 30, 2018

The regular meeting was called to order with the Pledge of Allegiance by Mayor Kaplan at 6:00 p.m. and requested a Moment of Silence in memory of Maxine Chapin a lifelong community member who recently passed.

Mayor Kaplan reported that earlier this evening the board's Neighborhood Walk was to the Berme Road Park. In the near future it is hoped to place a visitor's center as well as bathrooms in this area. Repairs are needed on the basketball courts as well as the tennis courts. It was requested that Manager Stoeckeler send a letter to our Senator and Assemblyman requesting grant funds to help improve the park.

Mayor Kaplan also reported on a joint meeting that included a number of Village, Town and School Board members as well as members of the community. Some goals from that meeting are to inquire about hiring a public relations person to advertise the positive aspects of our area.

#### POLICE DEPARTMENT

Mayor Kaplan thanked Chief Mattracion for chairing the joint meeting and the next meeting will take place in the near future.

Chief Mattracion reported that the weekend was extremely busy and he is very proud of his officers' handling of a very tense situation.

Firearms training will take place on June 16 as well as other training for his personnel.

#### MANAGER'S REPORT

Manager Stoeckeler reported that beginning June 3<sup>rd</sup> the paving of Route 209 will take place. Other items discussed were the sewer plant, water and sewer rate charges but will meet with the Water Commission before presenting any changes to the Board of Trustees.

Grants – Manager Stoeckeler has been in contact with Matt Blauer, grant writer, to discuss applying for Community Development Block Grant.

# MOTION TO HIRE MARK BLAUER-GRANT WRITER

Motion by Trustee Steinhoff, seconded by Trustee Gavaris to hire Mark Blauer in the amount of \$3,750 to apply for grant funds under the Community Development Block Grant Program.

Sewer Department – At a recent conference that Michael Ryman, Sewer Department Foreman, was attending he spoke with the administrator of the Community Development Block Grant for Inflow/Infiltration and was advised that a recent request was denied (hotbox) and to request something that would benefit our sewer lines system wide.

Motion by Trustee Steinhoff, seconded by Deputy Mayor Younger authorizing the Village Manager to send a letter to the administrator of the CDBG program requesting approval to line our clay sewer line pipes on Canal and Center Streets.

Manager Stoeckeler reviewed other projects that will be applied for using grant funds. Deputy Mayor Younger requested that we consider a community center for our youth to be included in any grant applications.

AUTHORIZING THE CONVEYANCE OF VILLAGE-OWNED PROPERTIES

Motion by Deputy Mayor Younger, seconded by Trustee Oliveras:

WHEREAS, this resolution has been submitted by the Mayor of the Village of Ellenville on behalf of the Village Treasurer; and

WHEREAS, the Village Treasurer has requested permission to accept payment of the full amount of back taxes on a certain parcels of real property acquired by the Village by reason of non-payment of taxes; and

WHEREAS, based upon the examination of the Village of Ellenville Board of Trustees, it has been determined that the following transaction does not pose a significant environmental impact and constitutes a Type II action in accordance with 6NYCRR, Part 617, of SEQRA, and does not require any determination or procedure under SEQRA; and now, therefore, be it,

RESOLVED, that upon receipt of such payment (within ten days) with respect to each parcel, the Mayor of the Village of Ellenville is hereby authorized to make, execute and deliver to the owner making payment, a quitclaim deed conveying the interest of the Village in the parcel, which quitclaim deed shall contain the covenant that the Village of Ellenville shall in no event be or become liable for any defects in title conveyed for any cause whatsoever, or that no claim or demand of any nature shall ever be made against the Village of Ellenville arising from such sales, conveyances, or any proceedings leading thereto,

and moves its adoption.

Trustee Gavaris also spoke about empty properties owned by the Village to consider contacting Ulster BOCES to work on their rehabilitation and then placing the renovated properties on the market.

Trustee Steinhoff stated that at a recent meeting there was a concern about recent released persons from the correctional facility waiting for the bus on Canal Street. Discussion ensued.

Trustee Gavaris spoke about before the Village sign any lease agreement with Spectrum Services that it be reviewed very carefully.

Trustee Steinhoff spoke about the empty storefront windows on Canal and Center Streets. The board will make this next this areas their next Neighborhood Walk.

Deputy Mayor Younger questioned if we invited Tom Moza to our next board presenting him with a Pride of Ellenville certificate.
