Official Election Results – Mayor Kaplan read the official elections results from the Mandatory Referendum of April 30, 2019 – YES – 227, NO – 60 TOTAL - 337.

Mayor Kaplan would like the Village Manager to write a letter to the County proposing that the remaining \$140,000.00 of the Ellenville Million money be used towards an ice skating rink and a tow for tubing. Mayor Kaplan wants to use this money before it goes back into the County's general fund.
