PETITIONERS & CORRESPONDENCES:

<u>Vinny Nigro</u> – Was before the Board tonight to speak about the Jim Decker Band. Mr. Nigro explained to the Board that the band will play about five songs on a flat bed, pack up, and move on to the next venue.

Mayor Kaplan addressed concerns that this event might draw crowds and ask if it was possible for the flat bed to move while they were playing. Mr. Nigro informed him that it could be done.

Mayor Kaplan suggested to Mr. Nigro to call the Chief to inform him that without having a place to gather the Village Board has agreed to this event.

POLICE REPORT

Chief Mattracion informed the Board that one of his' Officers tested positive for COVID and is currently at home resting.

Mayor Kaplan asked the Chief about the status on the 5th floor tenant who is still not in compliance.

Chief Mattracion stated that the Board of Health will be coming down to investigate and will order a cease-and- desist if he does not comply. If the tenant does not abide by the cease- and-desist order then he will be closed down just like any other business that refuses to comply.

Mayor Kaplan informed the Board that the 5th floor lease is subject to reasonable rules and regulations established by the Village.

Mayor Kaplan would like a motion establishing a rule that during the COVID Pandemic period that no one shall be in a common area of the Government Center without a mask and for those who are not able to medically tolerate a mask should contact the Village for other reasonable accommodations like wearing a face shield.

ATTORNEY REPORT:

Attorney Osgood spoke about the current 5th floor tenant situation and informed the Board that according to NYCOM they enforce according to the NYS Health Law and that it could lead to disorderly conduct and or a criminal nuisance charge.

Mayor Kaplan instructed Attorney Osgood to write a letter to the tenant on the 5th floor explaining that there are rules in the Village Government Center set forth and must be abided by. Mayor Kaplan would like this letter to be hand delivered.

BUILDING REPORT:

Code Enforcement Officer discussed with the Board outdoor displays.
