APPROVAL OF MINUTES

Motion by Trustee Steinhoff, seconded by Trustee Moschetta to

approve the minutes of September 14, 2020.

PETITIONERS & CORRESPONDENCES:

Rolling V Plaque Presentation – Due to prior commitments, Mr. Philip Vallone and Mrs. Vicky Reeves were not present to accept their certificate of appreciation for their generous donation during the Canal StrEATS family style outdoor dining.

Mayor Kaplan and his' wife, Marla Kaplan was also presenting coupons from local restaurants and coupons from Top Shelf.

<u>Council Woman Cassie Spoor</u> – Was before the Board tonight to speak on behalf of the Town of Wawarsing/Noonday Club to get permission to hold an Autumnal/Halloween House/Lawn/Business decorating contest in the Village on October 23, 2020 (resolution #6).

Council Woman Spoor also spoke about the issues at the pavilion and how the individuals that hang out there are harassing Village residence and Town Hall employees.

Mayor Kaplan informed her that the Board is looking into addressing this problem. Michael Jeter suggested putting up dawn to dusk signs in the pavilion area and also in all parks in the Village.

Mayor Kaplan would like Attorney Osgood to look into the dawn to dusk law for the next meeting.

<u>Paul Lonstein</u> – Was before the Board tonight inquiring about the amendment to the short term rental lodging use and wanted to address his' concerns.

Mayor Kaplan informed Mr. Lonstein that it was not on the agenda tonight but will be discussed at the October 14, 2020 Board meeting.

SEWER REPORT:

Motion by Trustee Steinhoff, seconded by Deputy Mayor Younger to authorize the expenditure of \$7,985.00 to APG Neuros for a 5 year service contract for the blowers at the Sewer Plant upon recommendation of the Sewer Department Foreman.

Motion by Trustee Moschetta, seconded by Deputy Mayor Younger to authorize the expenditure of \$1,920.00 to MTEK for BioAug to activate the sludge process at the Sewer Plant upon recommendation of the Sewer Department Foreman.

Motion by Trustee Moschetta, seconded by Trustee Steinhoff to authorize the expenditure of \$1,749.00 to MTEK for EnviroZyme's to decompose the grease at the Sewer Plant upon recommendation of the Sewer Department Foreman.

All in favor – Aye – motion carried

POLICE REPORT:

Chief Mattracion spoke to the Board on the following issues:

 Burglary at the Joseph Stoeckeler Memorial Park and Golf <u>Course</u> – Golf Carts - Investigating the burglary and following up on all leads.

Mayor Kaplan believes that the individuals who took the golf carts are kids only because flags from the first and second greens were also taken and anyone else would have just come in with a truck and drove away.

Mayor Kaplan would like Chris from the Shawangunk Journal to put in the paper that the Mayor and Board of Trustees will give the individuals that took the golf carts the opportunity to return the golf carts and will ask the Police not to prosecute. If they do not return the carts, and are caught the Board will ask the Police to aggressively prosecute the charges regardless who took them.

2) Halloween – Chief Mattracion suggests that due to COVID-19 and the issue of social distancing he believes that it is in the best interest of the Village not to authorize Halloween this year. Chief Mattracion also stated that if the Board has a better safe form of Halloween he is on board. Mayor Kaplan agreed with this in that regardless whether you trickor-treat or trunk-or-treat social distancing will still be an issue.

Motion by Trustee Steinhoff, seconded by Trustee Moschetta authorizing a curfew of 8:00 p.m. for Halloween for children under 18 years of age.

3) <u>Pavilion</u> – Spoke to the Board about the issues with the pavilion at great lengths.

Manager Warren spoke about the following:

Attorney Osgood has reviewed the agreement and has no legal objection.

2) Department of Public Service Utility Notice – The Village receive a utility notice from the Department of Public Service in regards to COVID-19 and the Village Manager ask if the Board wanted this notice to be sent out with the water and sewer bills.

The Board authorizes the Village Clerk to insert this notice with the water and sewer bills for this quarter.
