	Mayor Kaplan expressed the Board's appreciation to the American Legion, Cook Taylor Post No. 111, for their donation of a new flag pole to the Government Center. A dedication ceremony was held earlier this evening. It had been recommended that the flag be lowered at half mast in memory of Mayor Elkin but we have since learned that flags are not to be placed at half mast unless the President of the United States or Governor of New York directs that a flag be lowered. The appropriate way to honor the memory of a local dignitary is to take a black strip approximately the size of a stripe on a flag and fly it with the flag, which was done for Mayor Elkin.

PETITIONERS & CORRESPONDENCE	<u>Sam Bugna – Ellenville Wawarsing Youth Commission</u> was before the board tonight requesting the use of the "Canal Street Ticket Office" on Berme Road. Ms. Bugna informed board members that after August there will not be any space at the school to be used by the Youth Commission. Mayor Kaplan requested that Attorney	

Cataldi prepare a short lease for the use of the building with the YMCA with the provision that either side can terminate this lease on a 45 day notice.

Mrs. Bugna informed board members that as of today 198 children are registered for the summer program and there is a wait list for any additional children.

## MOTION TO GRANT APPROVAL FOR THE YOUTH COMMISSION TO USE THE "TICKET OFFICE" #060908-01

Motion by Deputy Mayor Younger, seconded by Trustee Steinhoff authorizing a one year lease between the Village of Ellenville and the Ellenville Wawarsing Youth Commission to use the Canal Street Ticket Office subject to a 45 day termination notice by either side and minor repairs will be done by the tenant and no major repairs will take place without authorization by the Village Board.

Mayor Kaplan questioned Mrs. Bugna about any program that young adults would be able to either mow or shovel for senior citizens. Trustee Steinhoff stated that the YMCA does have a Young Business Leadership Program and Mrs. Bugna will look into coordinating this matter.

<u>Hosanna Assembly of God –</u> Rev. Morales was before the board tonight to discuss the possibility of his Church hosting carnival activities on the Church property on Friday, June 20, 2008. Mayor Kaplan informed Reverend Morales that this is the night before the Fireman's Parade and Chief Police also stated that this weekend would not be a good time to hold a carnival. It was requested that Reverend Morales pick another date and coordinate this with the Police Chief and for the Chief to contact the Shadowland Theater with that date and then Reverend Morales return to the Village Board for their approval.

<u>Christ Lutheran Church</u> – Letter received requesting permission to hold a yard sale on their Church grounds on July 10, 11 & 12, 2008.

Motion by Deputy Mayor Younger, seconded by Trustee Steinhoff granting permission to the Christ Lutheran Church to hold a yard sale on the church grounds on July 10, 11 & 12, 2008. All in favor - Aye - motion carried

<u>T.A.P. Enterprises</u> - Letter received requesting permission to hold a one day Tool and General Merchandise Sale at Scoresby Hook, Hook and Ladder Co. #1 on July 19, 2008. The Village Board of Trustees acknowledged receipt of this letter.

<u>Time Warner Cable</u> – The Village Board acknowledged receipt of a check in the amount of \$14, 126.84 from Time Warner Cable pursuant to their franchise agreement.

<u>Chamber of Commerce</u> – Request of use of the Hunt Memorial porch and electricity for "Music in the Square".

Motion by Trustee Lopez, seconded by Deputy Mayor Younger to grant approval to the Chamber of Commerce for use of the Hunt Memorial grounds on July 12, 19 and 26, 2008 subject to consent by the Hunt Memorial Committee which we strongly urge. All in favor - Aye - motion carried

<u>Joel Schriebman</u> – was before the board tonight about him obtaining a copy of a local franchise agreement and Mayor Kaplan requested that Mr. Scrieberman highlight the major differences. Mr. Scrieberman also spoke about his contact with the Superintendent of Schools in reference to Channel 20.

<u>Michael Jeter</u> – Thanked the Village Board for sending him to school recently and he gave a brief synopsis of this seminar. Mayor Kaplan stated that he has recently met with the Village engineers to discuss the maintenance operational cost of Village Hall. It was recommended that we should contract with a with a plumber and electrician for routine maintenance. Mayor Kaplan requested that Mr. Jeter be involved in this process. <u>NAACP</u> – Deputy Mayor Younger on their behalf requested permission to hold their annual health living walk on June 28, 2008 on the grounds of the Hunt Memorial Building.

<u>Ulster County Habitat for Humanity</u> – Inspector Schug told board members that the Ulster County Habitat for Humanity submitted their building plans and he requested authorization to waive the \$594.00 permit fees since this was a vacant piece of land and now will be now be placed on the tax rolls.

Motion by Deputy Mayor Younger, seconded by Trustee Steinhoff to waive the \$594.00 building permit fees for the Ulster County Habitat for Humanity since this is taken a vacant piece of land and putting a house on it by a non-profit organization and then placing it on the tax rolls.

## POLICE DEPARTMENT

Chief Mattracion reviewed with Board members an update on the Fireman's Parade that will be held on June 21, 2008. Chief Mattracion stated that residents in the Green Acres section of the Village will be notified of the events that will be taken place in the neighborhood.

Chief Mattracion also spoke about the 4<sup>th</sup> of July parade and their upcoming events.

Chief Mattracion also spoke about last week's group of juveniles that were having difference of opinions and the Police Department and the school handled this in a quick and rapid response. Mayor Kaplan asked about the potential of gangs in Ellenville and Chief Mattracion stated that we do not have any organized gangs in the Village. Mayor Kaplan thanked the Chief for his pro-active response to any problems in the Village.

Trustee Lopez questioned if the police are watching the Village Motel and also Mayor Kaplan requested that an officer be assigned to the Shadowland Theater when the show ends at night.

# RESOLUTION OF THE VILLAGE BOARD OF ELLENVILLE IN SUPPORT OF WESTERN MOHEGAN TRIBE AND NATION GAMING CASINO #060908-06

Motion by Trustee Lopez, seconded by Deputy Mayor Younger:

WHEREAS, on January 5, 2001 the Western Mohegan Tribe and Nation purchased the former Tamarack Hotel located on Route 209 in Greenfield Park, Town of Wawarsing, County of Ulster, New York, and

WHEREAS, the Tribe and its designated developer seek to construct a recreational facility consisting of a 2000-4000 room hotel(s), 200,000-300,000 square feet of casino class III gaming, multiple restaurants, retail space, a 3000 seat show theater, and other ancillary facilities and,

WHEREAS, said recreational facility will represent major full time direct and indirect local employment as well as substantial increased direct and indirect local economic output and,

WHEREAS, the Tribe and its designated developer represent that revenue sharing shall be allocated annually at twenty (20%) per cent on net earning on all slot machines, of which two (2%) per cent shall be paid to the Town of Wawarsing, one (1%) to the Village of Ellenville, one million (\$1,000,000) dollars to the Ellenville Hospital, and one million (\$1,000,000) dollars to the local school district (net earnings is defined as gross income from gaming operations only, less gaming taxes assessed by all entities and less all gaming payouts) and,

WHEREAS, the Village of Ellenville has been experiencing severe economic difficulties including job loss.

RESOLVED, that the Village Board of Ellenville welcomes the efforts of the Tribe and its designated developer to build said recreational facility and it is

FURTHER RESOLVED that the Village Board of Ellenville urgently requests the New York State Government to recognize the Tribe and its Ulster County reservation, and to promptly enter into a compact with the Tribe for the development of said recreational facility.

## MOTION FOR THE APPROVAL AND ENDORSEMENT OF GRANT APPLICATION FOR SAM'S POINT PRESERVE ROAD RESTORATION PROJECT #060908-06

WHEREAS, as a requirement under the rules of these programs, said not-for-profit corporation must obtain the "approval/endorsement of the governing body of the municipality in which the project will be located";

NOW, THEREFORE, be it resolved by this august body that the Village Board of the Village of Ellenville does approve and endorse the application for a grant under the Environmental Protection funds for a park project known as "Sam's Point Preserve Restoration Project" and located within this community.
